CALL FOR RESEARCH TENDERS – 'Co-designing the principles for defining low impact fishing'

In the recent Fisheries White Paper, the UK Government outlines a desire for an efficient but sustainable fishing industry. With technological advances having driven greater efficiency, such as where modern smaller boats have been able to catch more fish than they have previously, existing approaches to considering sustainability may no longer have their original utility. As the UK leaves the European Union and takes back control of its waters in a new era of fisheries governance, there is distinct opportunity to consider new criteria for defining 'low impact fishing', and to replace current definitions used for fishing vessels, such as the 'under 10 metre' categorisation, while considering what low impact fishing means across the commercial fleet and recreational sector.

This invitation to tender is for an original piece of work combining social science and

stakeholder facilitation approaches to develop a framework of principles for low impact fishing, and to agree the processes for applying them. The scope of this work extends only to England for operational reasons, but it is recognised the outputs may be of interest at a UK-wide scale and beyond.

Deadline for tendering is 28th August 2019. This is an open call from the UK Department of Environment, Food, and Rural Affairs (Defra).

Seafood Innovation Fund

The Centre for Environment, Fisheries and Aquaculture Science (Cefas) is an
Executive Agency of Defra. Cefas are administering the Seafood Innovation Fund
(SIF) on behalf of Defra. Cefas will run several calls throughout the 3-year
programme (ending March 2022).

This call opens on Friday 19th July and closes on Thursday 12th September. There are two options for applications, either smaller feasibility studies, or larger full R&D projects. Feasibility studies are designed to test new ideas and can be up to 3 months. Full R&D projects are for more developed ideas that can be delivered in up to 18 months. Feasibility studies will be expected to apply for full R&D funding following a successful outcome in the feasibility stage.

The aim of this programme is to kick start a step change in productivity, innovation and sustainability of the UK's fishing, aquaculture and seafood industries, leading the UK to be international exemplars of good practice in the seafood sector.

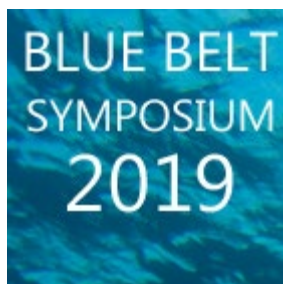

**Marine Social Science Discussions at the First UK Overseas Territories
Blue Belt Symposium**

On 29-31 July 2019, the Ascension Island Government, the University of Exeter, Great British Oceans coalition and the UK Government's Blue Belt Programme jointly hosted the first Blue Belt Overseas Symposium at the University of Exeter's Cornwall Campus focusing specifically on the topic of 'big ocean' management. With many of the UK Overseas Territories (OTs) at pivotal moments in the future management of their Exclusive Economic Zones, the Symposium provided an opportunity for Territory representatives to meet face-to-face and forge personal relationships by sharing knowledge and experiences for addressing common challenges across marine management. The UK-based agencies and organisations involved in delivering the UK Government's Blue Belt Programme were also in attendance to help celebrate the achievements of Blue Belt and inspire its future progress and extension into new areas, for example the Caribbean OTs.

Northern Ireland Fishing Business Continuity Research Call for expressions of interest.

Fishing plays an important socio-economic and cultural role in coastal communities throughout the UK. Traditionally fishing has been a family business handed down through generations. However evidence suggests that fishing has become a less desirable career choice and there are fewer youngsters joining the industry. The fishing industry is often described as aging and anecdotal evidence suggests that many vessel owners operating in the Northern Irish fleet are approaching retirement age. As business owners approach retirement it is important for them to make succession plans to ensure business continuity and secure future supply.

The Northern Irish fishing industry has requested a study in this area to understand the extent of succession planning in the Northern Irish fishing fleet. A qualitative or mixed methods approach is suggested and it is anticipated that this study may provide the foundation to a larger piece of work and could be used as a framework for similar studies in other fishing communities. It is proposed that Seafish jointly supervise an Honours or Masters student to undertake this study in 2020 with a

University either located in or with links to Northern Ireland. Seafish are expressions of interest from potential supervisors.

Success in the conservation of marine mammals often relies upon the adoption of one or more sustainable behaviours by a specific group of people.

Unfortunately, scientists and conservationists typically struggle to induce such changes due to the belief that people simply lack the knowledge and understanding required. In fact, provision of information is not enough to incite behavioural change and it may, on occasion, actually set back the wider cause. This full-day workshop is designed to introduce marine mammal scientists to existing tools that they may not be aware of to improve their ability to achieve the changes needed to affect conservation, and will be run by members of the Society for Conservation Biology's Social Science & Conservation Marketing and Engagement Working Groups.
