### High Level Working Group Co-ordinator – Saving our Seas and Oceans

An exciting opportunity has arisen for a Co-ordinator at the University of St Andrews, Scottish Oceans Institute. The role is part of the preparation for a major initiative designed to encourage behavioural changes in the way that society understands and takes concrete actions to reduce our harmful impacts in seas and oceans. A high level Working Group is being established which will involve a global telecommunications company, experts in behavioural insight, specialists in analytics and marketing, public communication of science, and internationally recognised experts in the effects of global change and climate change. The Co-ordinator will be responsible for assisting the Working Group to drive forward this initiative,

culminating in the delivery of a strategy focusing on high priority areas and defining specific recommendations and actions to be presented to major corporate partners.

The role may be full or part time and will be for a period of 6-8 months in the first instance.

### Seafood Innovation Fund

The Centre for Environment, Fisheries and Aquaculture Science (Cefas) is an Executive Agency of Defra. Cefas are administering the Seafood Innovation Fund (SIF) on behalf of Defra. Cefas will run several calls throughout the 3-year programme (ending March 2022).

This call opens on Friday 19<sup>th</sup> July and closes on Thursday 12<sup>th</sup> September. There are two options for applications, either smaller feasibility studies, or larger full R&D projects. Feasibility studies are designed to test new ideas and can be up to 3 months. Full R&D projects are for more developed ideas that can be delivered in up to 18 months. Feasibility studies will be expected to apply for full R&D funding following a successful outcome in the feasibility stage.

The aim of this programme is to kick start a step change in productivity, innovation and sustainability of the UK's fishing, aquaculture and seafood industries, leading the UK to be international exemplars of good practice in the seafood sector.
